

STATUTORY DECLARATION

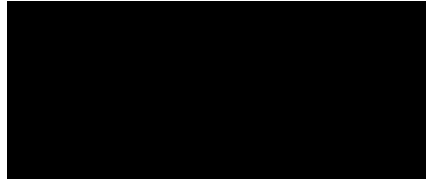
I, WILLIAM GEORGE ANDREWS, Chairman of the Trustees of the Frimley Fuel Allotments Charity Number 231036 ('the trustees') ('the charity') DO SOLEMLY and SINCERELY DECLARE as follows:-

1. I make this Statutory Declaration in accordance with the provisions of the Highways Act 1980 Section 31 Subsection 6.
2. The trustees are currently and have been since at least 1826 as verified by the Waste and Commons within the Manor of Frimley and Parish of Ash Inclosure Award 1826 the owners of the land known as Frimley Fuel Allotments in the County of Surrey.
3. On the 29th. Day of January 1998, I, on behalf of the trustees, deposited with Surrey County Council, being the appropriate council, a statement accompanied by a map ('the map') delineating the charity's land by red edging which stated that the ways coloured green on the map had been dedicated as bridleways, the way coloured purple had been dedicated as a footpath and no other ways have been dedicated as highways over the charity's land.
4. No additional ways have been dedicated over the land shown edged red on the map since the statement dated the 14th. Day of January 1998 and at the present time the charity has no intention of dedicating any more rights of way over its property.


