

**STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980**

I Robert McCosker [landowner] DO SOLEMNLY AND SINCERELY DECLARE as follows:-

- 1 I am and have been since 17 JANUARY 2000 [day, month, year] the owner of the land known as PRIMROSE HILL [name of farm, etc] more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2 On the 11th [day] day of APRIL 2000 [month, year] I (or my predecessor in title [name]) deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that (~~the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with public vehicular status*~~) (the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways*) (the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths*) (no ways had been dedicated as highways over my property*).
- * 3 On the [day] day of [month, year] I (or my predecessor in title [name]) deposited with Surrey County Council, being the appropriate Council, a statutory declaration dated [day, month, year], stating that no additional ways (other than those coloured on the plan accompanying this declaration) had been dedicated as (highways with vehicular status*) (bridleways*) (footpaths*) since the deposit of the Statement referred to in paragraph 2 above.
- * 4 No additional ways have been dedicated over the land edged red on the plan accompanying this declaration (since the statement dated 11th APRIL 2000 [day, month, year] referred to in paragraph 2 above*) (since the date of the statutory declaration referred to in paragraph 3 above*) (other than those (~~highways with vehicular status*~~) (bridleways*) (footpaths*) coloured on the plan accompanying this declaration*).
- * 5 Upon the said plan there is marked in blue ^{AND PURPLE} a path for which I give consent to members of the public to ~~walk~~ ride over. However, this path is not being dedicated to the public at large to use. AS A BRIDLEWAY

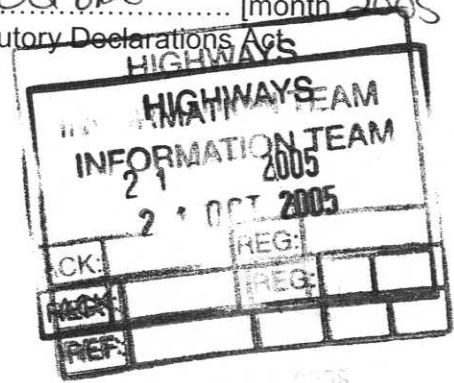
