

**STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980**

- 1 I am and have been since 1995 the owner of the land known as Rabies Heath Field and Main Road more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2 On the 22nd day of February 2011, I deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that no ways had been dedicated as highways over my property.

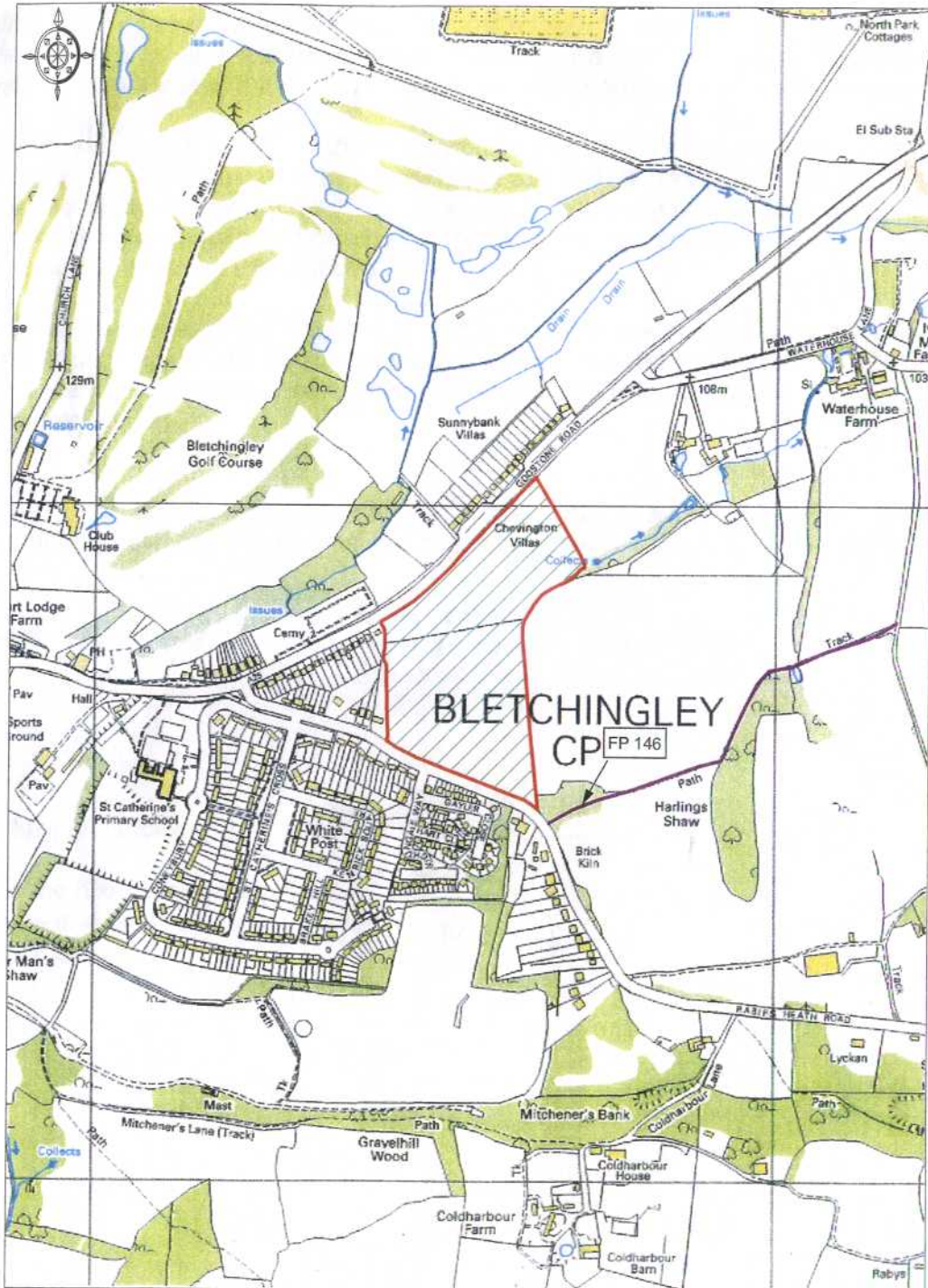

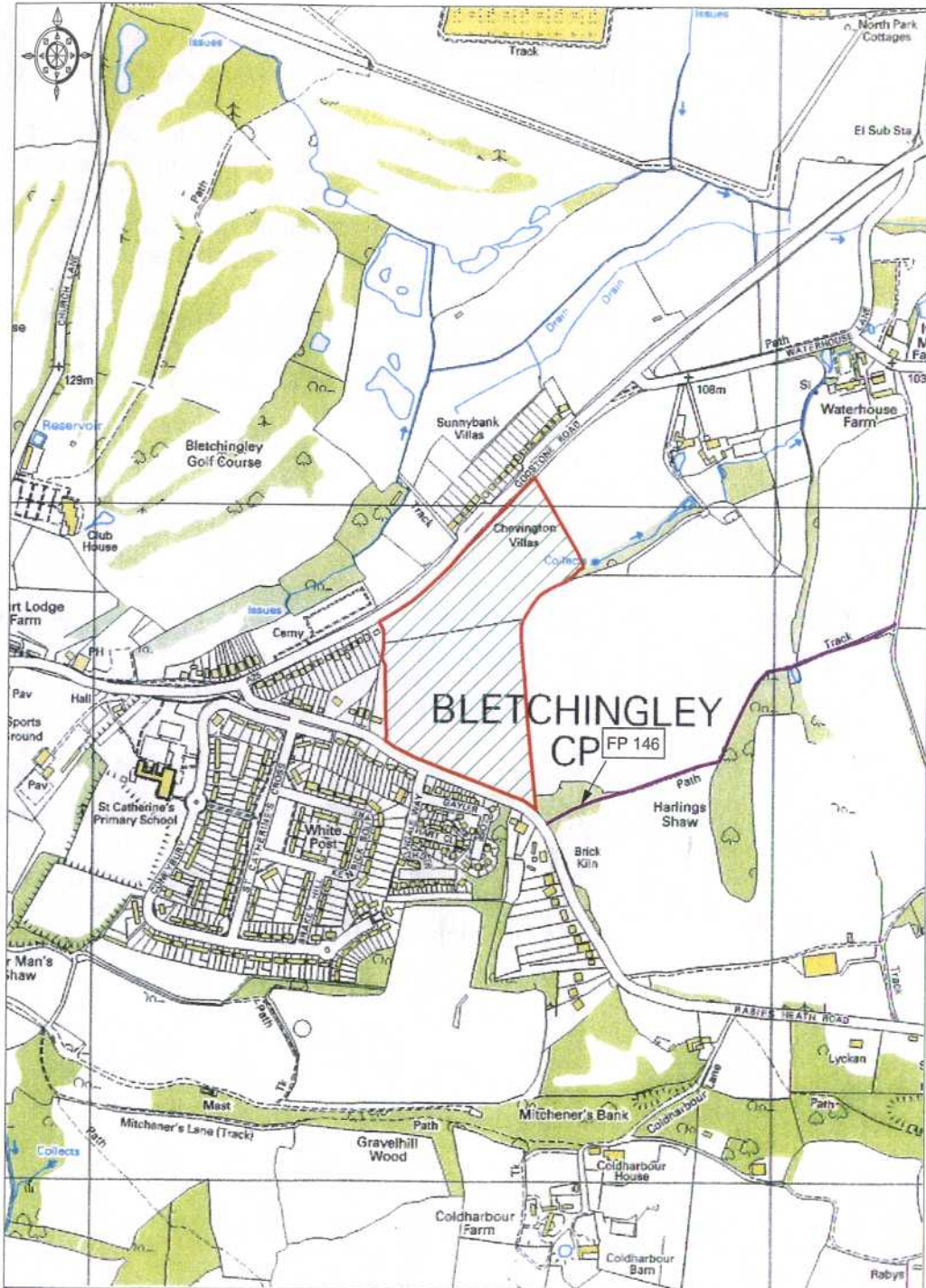
