DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I have been since 16 October 2006, the owner of the land known as Brook Meadows, Cranleigh, Surrey, GU6 8QU (Brook Meadows) more particularly delineated on the plan accompanying this declaration and marked NAG 1 and thereon edged red with my sisters Jane Margaret Hartley and Emma Elizabeth Beamish

2. On the 5th day of August 2008 I deposited with Surrey County Council, being the appropriate Council, a statement dated 31 July 2008 accompanied by a plan delineating Brook Meadows by red edging, which stated that no ways over the land had been dedicated as highways. There is now produced to me and marked NAG 2 a copy of the said statement and plan. Surrey County Council acknowledges the deposit of the statement and plan on 14 August 2008.

3. No ways have been dedicated over Brook Meadows since the statement dated 31 July 2008 referred to in 2 above and at the present time, I have no intention of dedicating any public rights of way over my property.


