

STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

I, Derek Lloyd representing Surrey County Council, (the landowner) DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. Surrey County Council is and has been since 27th September 1947, 13th October 1947, and 16th April 1962, the owner of the land known as Chobham Youth Centre in Windsor Road, Chobham, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On 26th August 2003 I deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 26th August 2003 referred to in 2 above.
4. Upon the said plan there is marked in blue a path for which I give consent to members of the public to walk over. However, this path is not being dedicated to the public at large to use.

AND I MAKE this solemn declaration on the 23rd September 2003 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

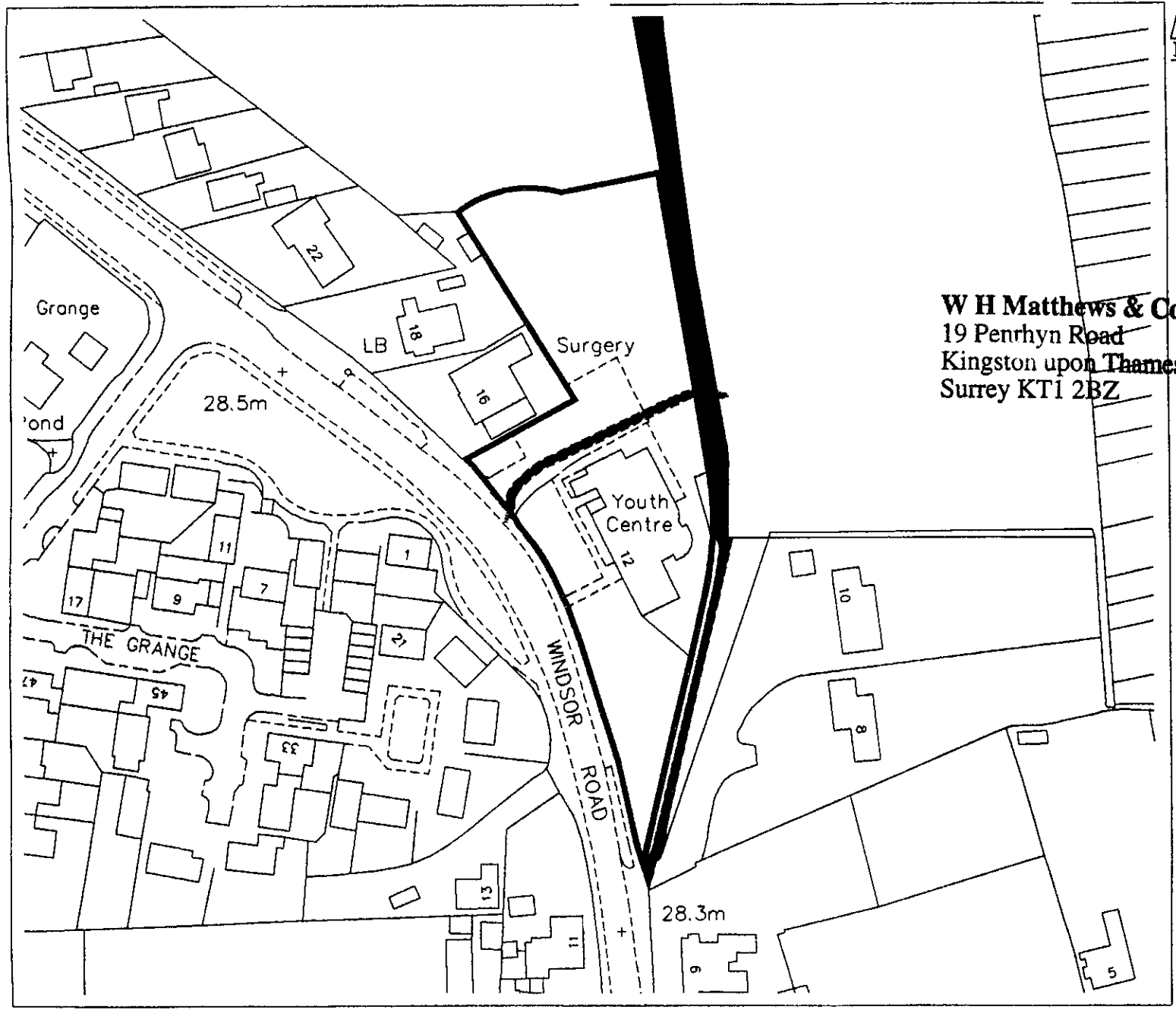
