
PART C: Declaration under section 31(6) of the Highways Act 1980

1. The Council of Almoners of Christ's Hospital is the freehold owner of the land described in paragraph 4 of Part A of this form and shown edged red on the map accompanying this declaration.
2. On 24 March 2017 I deposited with Surrey County Council, being the appropriate council, a statement accompanied by a map showing the property edged red which stated that:
 - a) The way shown dashed purple on the accompanying map had been dedicated as a public footpath.
 - b) No other ways over the land shown edged red on the accompanying map have been dedicated as highways.

No additional ways have been dedicated over the land edged red on the map referenced in paragraph 1 above since the statement dated 20 March 2017 referred to in paragraph 2 above and at the present time The Council of Almoners of Christ's Hospital have no intention of dedicating any more public rights of way over the property.

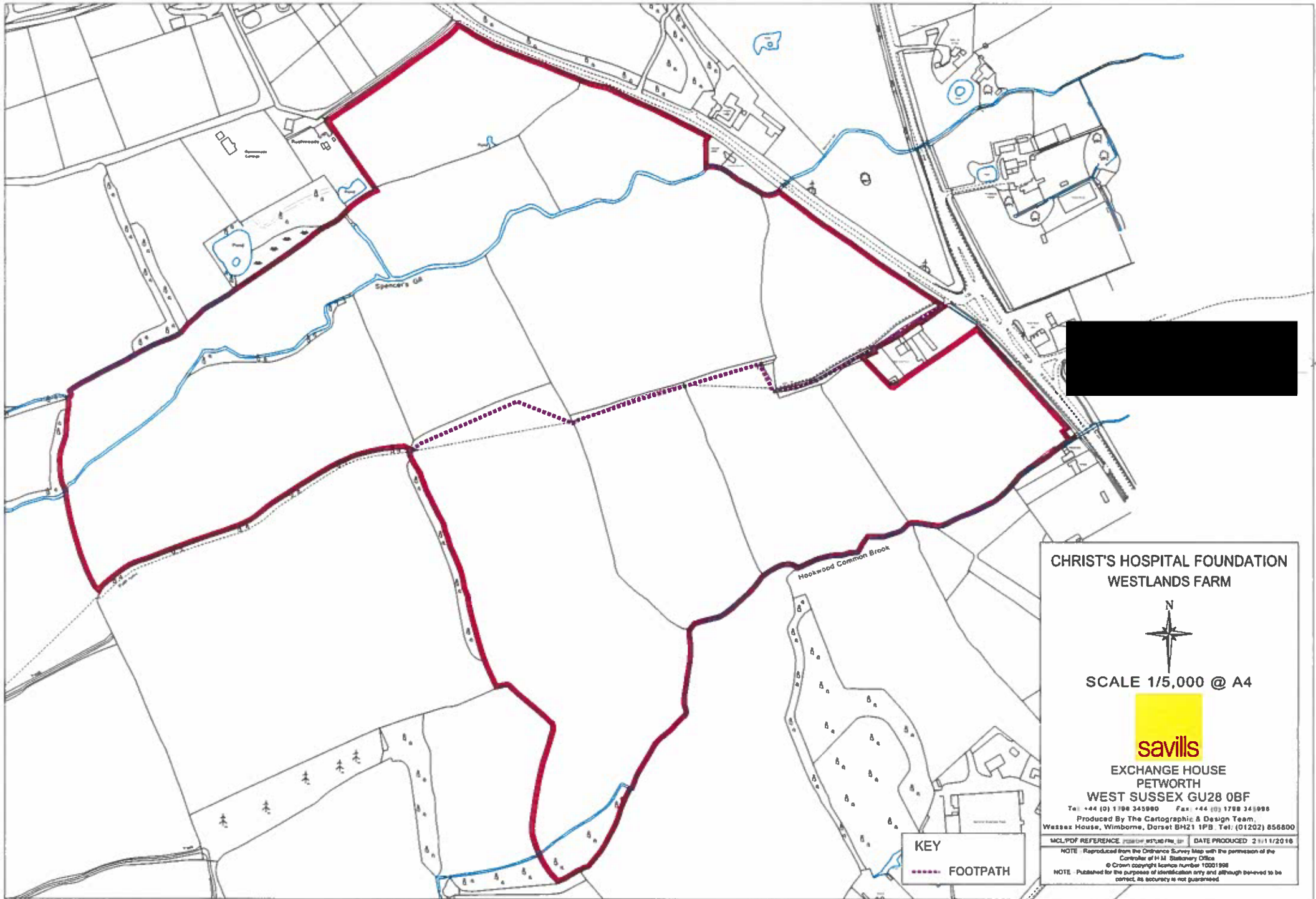
