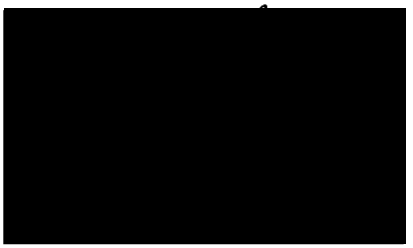
1. This Statutory Declaration constitutes a Statement for the purposes of Section 31(6)(b) of the Highways Act 1980.
2. We are (in our capacity as trustees as aforesaid) together the owner (within the meaning of Section 31 of the Highways Act 1980) of the land in the County of Surrey comprised in the estate vested in us and known as The Albury Estate shown edged red on the plan now produced to us marked "MCGB1".
3. The ways shown on the said attached plan as follows (namely):-
 - (i) The public bridle ways shown thereon in green
 - (ii) The public footpaths shown thereon in purple
 - (iii) The byways open to all traffic shown thereon in brown (each with the right of way numbers allocated to them by the Surrey County Council)are the ways (and the only ways) over that land which we

admit to have been dedicated as public highways.

- 4. No other ways over that land have to our knowledge been dedicated as public highways.

And we made this solemn declaration conscientiously believing the same to be true and by virtue of the Statutory Declarations Act 1835.

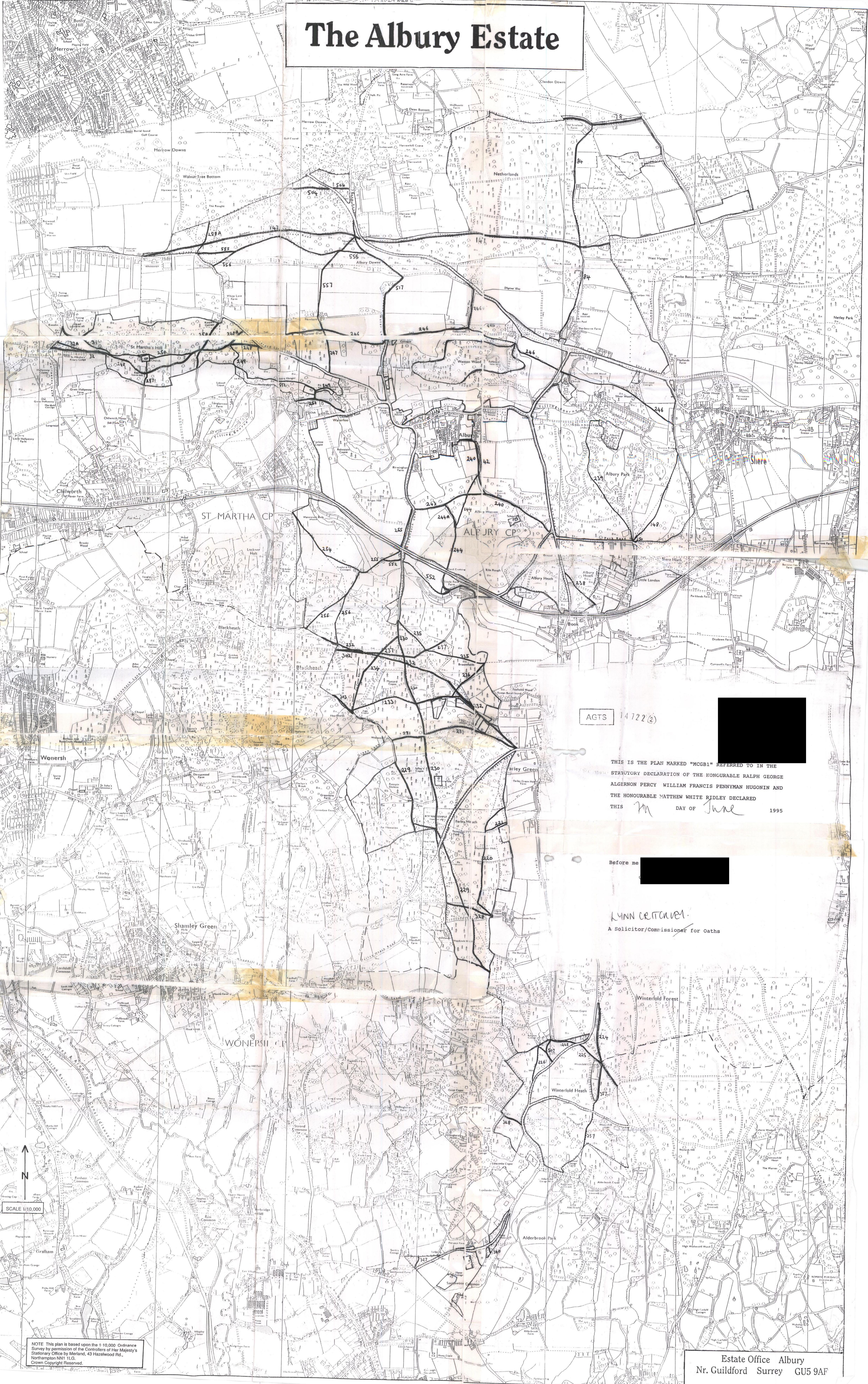
