

STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

The Greenmeads Residents Association Ltd for and on behalf of the Meads Road and Green Lane landowners DOES SOLEMNLY AND SINCERELY DECLARE as follows: -

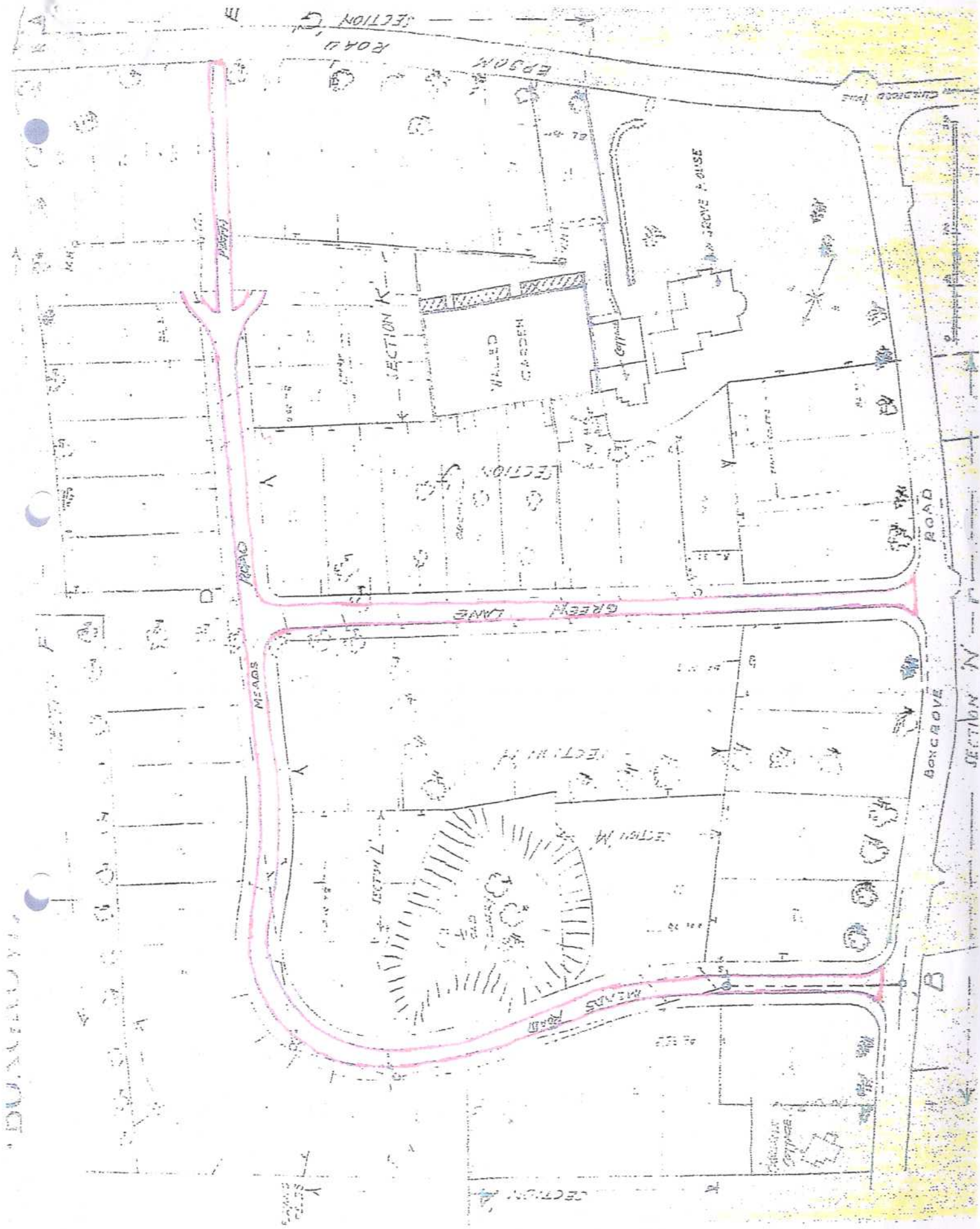
- 1 The residents of Meads Road and Green Lane and their predecessors have been since 21st August 1933 the owners of the land adjoining Meads Road and Green Lane and of the path between Meads Road and Epsom Road more particularly delineated on the plan accompanying this declaration and thereon edged red.
 - 2 On the 13th day of June 2011 the Greenmeads Residents Association Ltd deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating the land by red edging which stated that no ways had been dedicated as possessing a right of way over Meads Road and Green Lane and the path from Meads Road to Epsom Road to anyone other than the owners.
 - * 3 On the 26th [day] day of August 2011 [month, year] the Greenmeads Residents Association Ltd deposited with Surrey County Council, being the appropriate Council, a statutory declaration dated 23rd August 2011 [day, month, year], stating that no additional ways (other than those coloured on the plan accompanying this declaration) had been dedicated as possessing a right of way over Meads Road and Green Lane and the path between Meads Road to Epsom Road since the deposit of the Statement referred to in paragraph 2 above.
 - * 4 No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since neither the statement dated 13th June 2011 referred to in paragraph 2 above nor since the date of the statutory declaration referred to in paragraph 3 above.
