

## STATUTORY DECLARATION

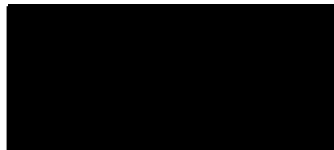
### MADE UNDER SECTION 31 HIGHWAYS ACT 1980

I, **Omar Camille Harmon** of 65 Ockendon Road, London N1 3NL, do solemnly and sincerely declare as follows:-

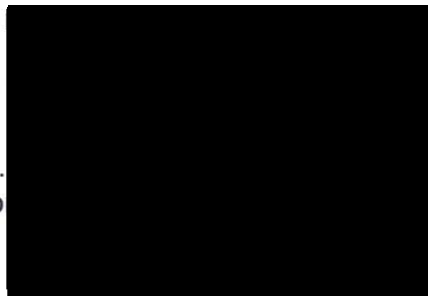

3. I make this declaration in accordance with the provisions of Section 31 of the Highways Act 1980.
4. A public footpath, namely, Right of Way Number 54 Abinger is marked in green on the attachment plan marked "B". I admit that this footpath has been dedicated as a highway.
5. I declare that there are no additional ways of any sort over the property which have been dedicated as highways and I do not recognise any additional public rights of way over the property whatsoever.
