

STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

I **Joanna Lawson** being the Company Secretary employed by Barnardo's of Tanners Lane Barkingside Ilford Essex IG6 1QG DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. Since 22nd January 2002 Barnardo's, The Cancer Research Campaign and The Royal Society for the Prevention of Cruelty to Animals ("the Charities") have been the owners of the land known as Land on the west side of Bonehurst Road Horley Surrey and more particularly delineated on the plan accompanying this Declaration and thereon edged red.
2. On 26th August 2010 the Charities deposited with the Surrey County Council, being the appropriate Council, a Statement accompanied by a plan delineating the said Land by red edging which stated that, other than a single public footpath as identified in orange on that plan, no ways had been dedicated as highways over the said Land.
3. To the best of my knowledge and belief, no additional ways have been dedicated over the land edged red on the plan accompanying this Declaration since the Statement dated 26th August 2010 referred to in paragraph 2 above and at the present time the Charities have no intention of dedicating any more rights of way over the said Land.

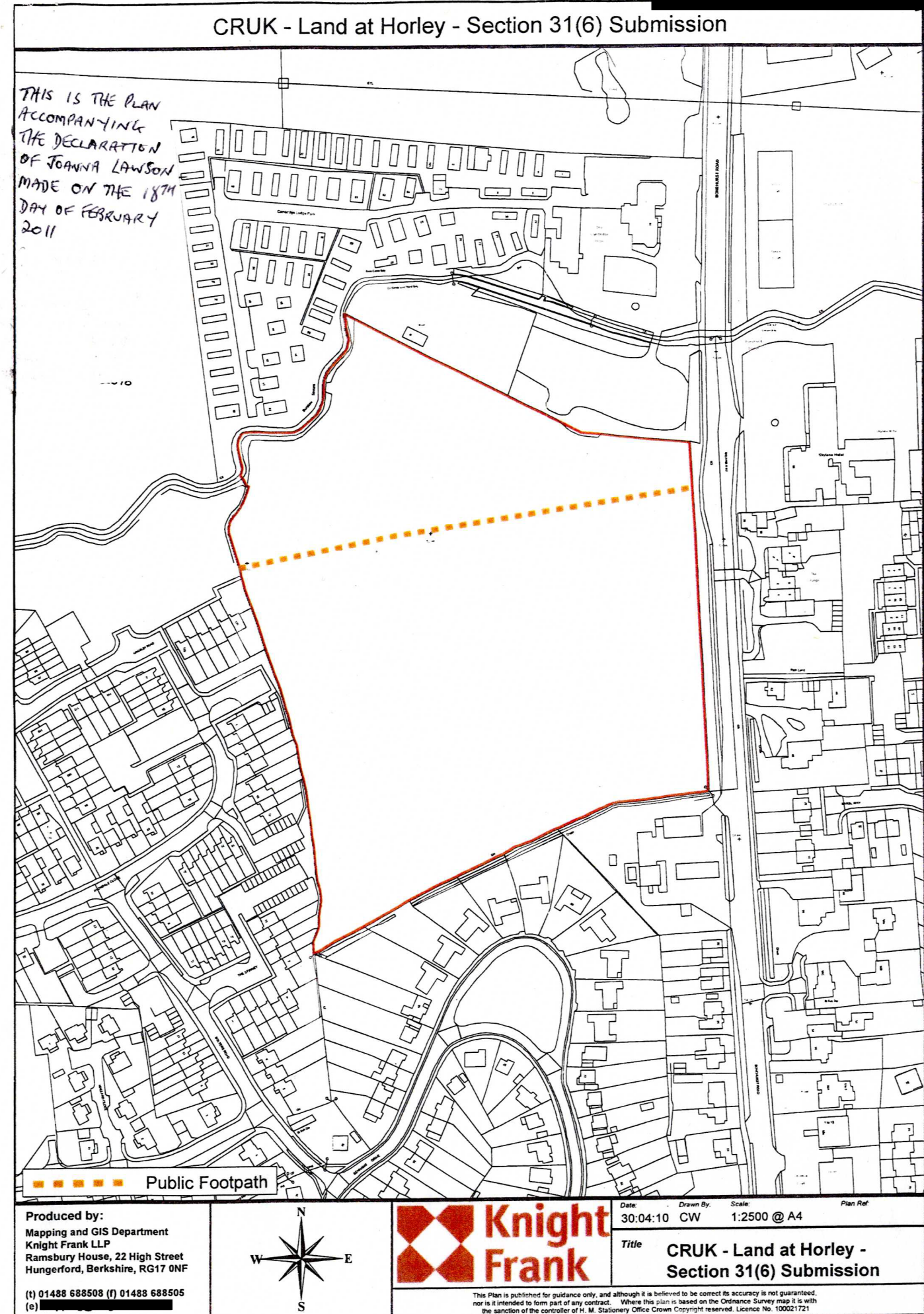

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

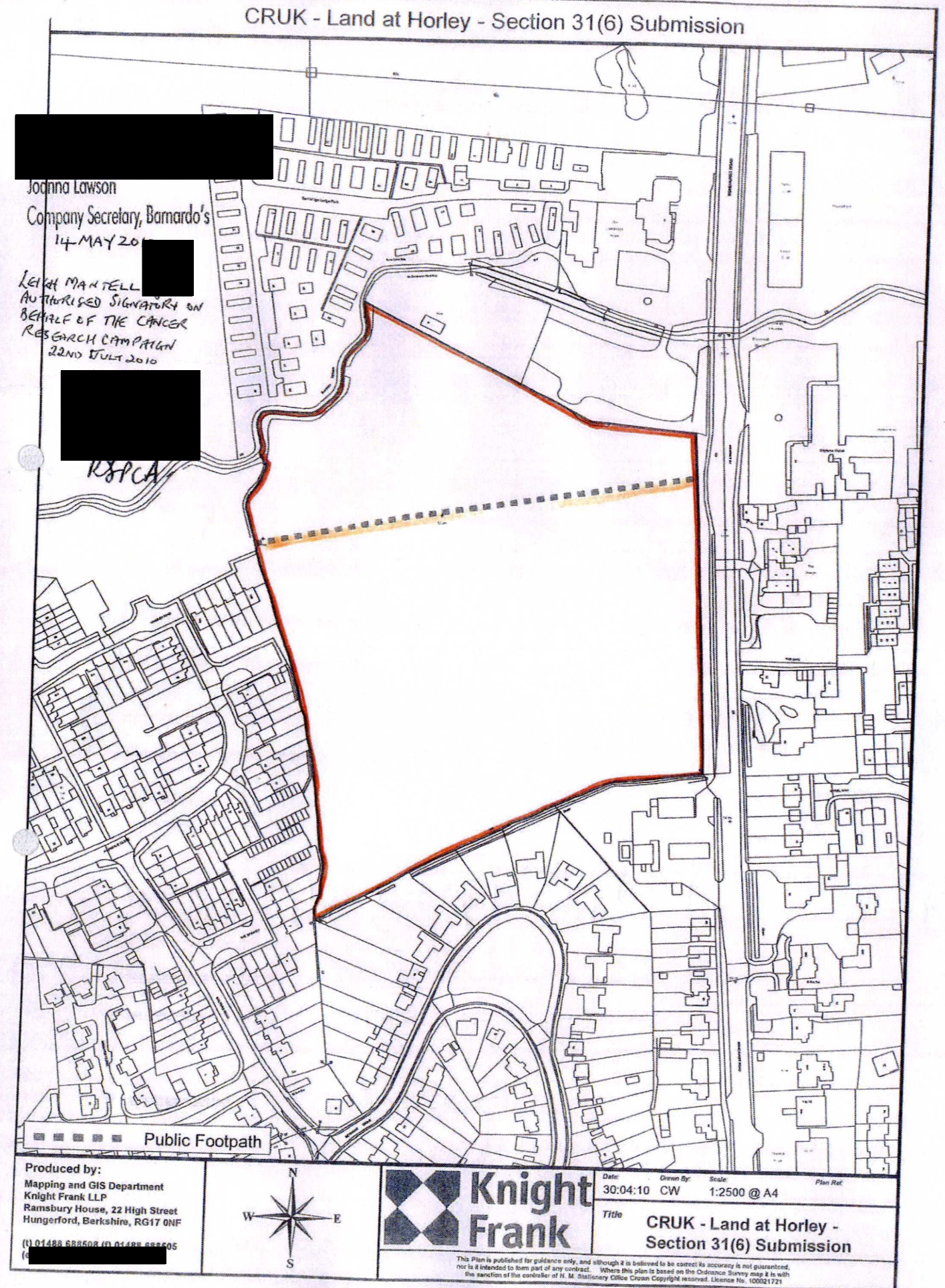



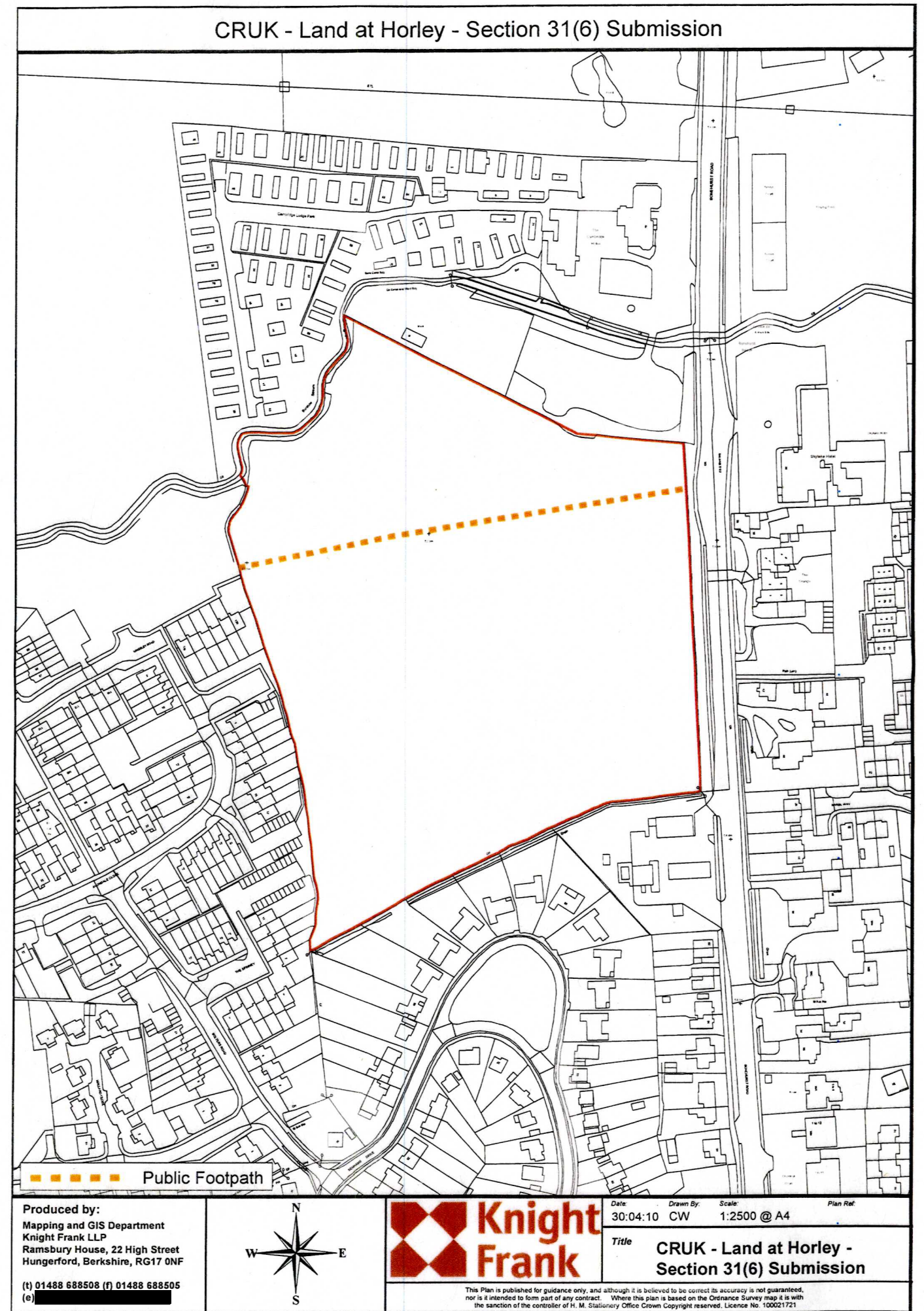
