

STATUTORY DECLARATION

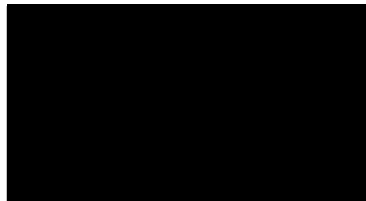
SECTION 31(6) OF THE HIGHWAYS ACT 1980

I Barry Anthony James DO SOLEMNLY AND SINCERELY DECLARE as follows.

1. I am and have been since 21 October 1996 the owner of the land known as Westbury Barn, Priorsfield Road, Compton more particularly delineated on the map accompanying this declaration and thereon edged red.
2. On the 2nd day of October 1997 I deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated that the way coloured purple on the said map and on the map accompanying this declaration had been dedicated as a footpath. No other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 2 October 1997 referred to in 2 above other than the footpath marked in the appropriate colour on the map accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.

AND I MAKE this solemn declaration on the 6th day of October 1997 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.


DEPOSIT OF STATEMENT AND MAP

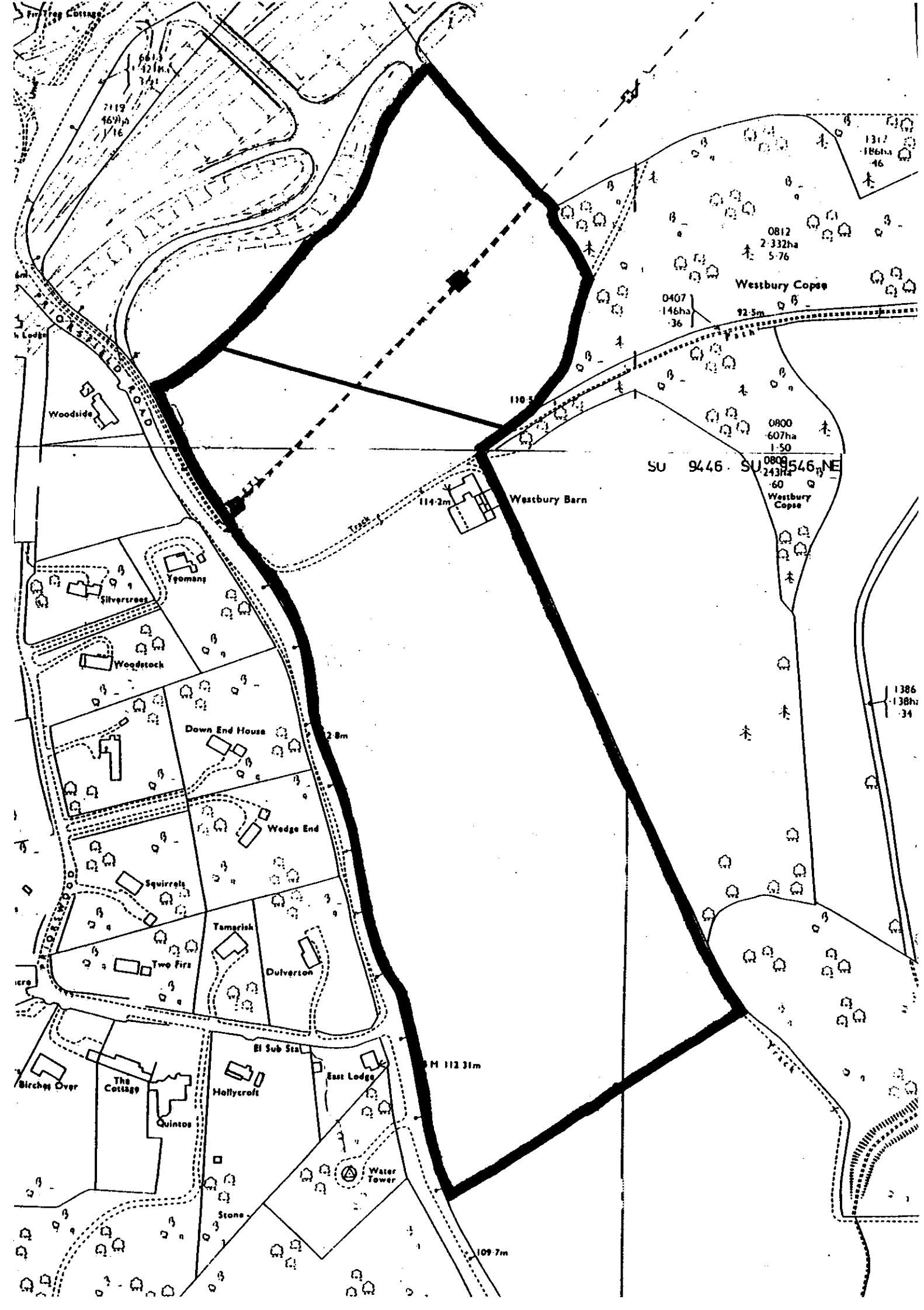
