

**STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980**

We, Wharf Land Investments (Jersey) Limited (the "Company"), DO SOLEMNLY AND SINCERELY DECLARE as follows:-

- 1 The Company has been since 11 December 2006 the owner of the land known as Wisley Airfield more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2 On the 11 March 2008 the Company deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating its property by red edging which stated that the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways and the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths.
- 3 No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 11 March 2008 referred to in paragraph 2 above.

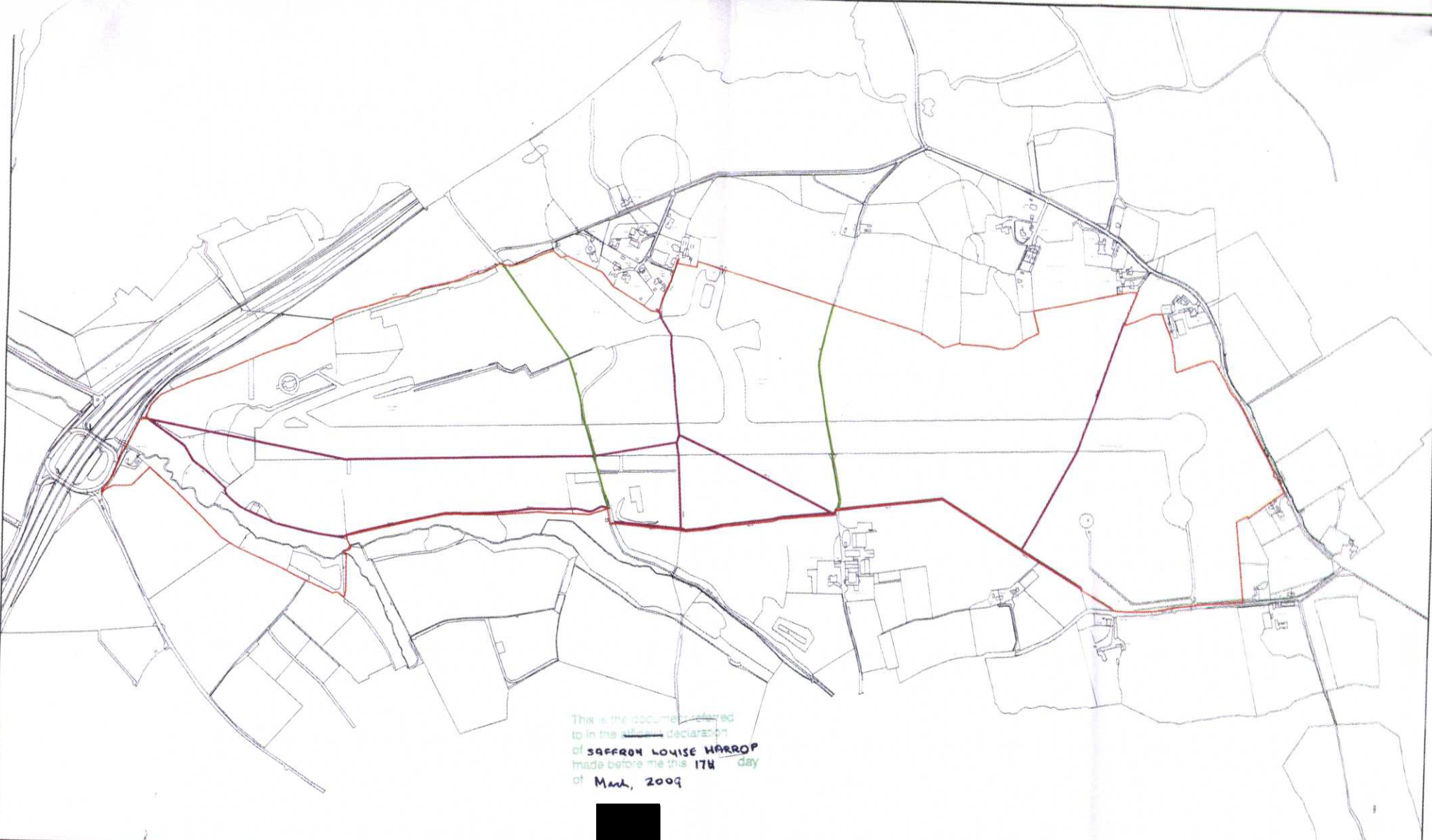
