Statutory Declaration

Highways Act 1980 Section 31 (6)

I, Andrew Barton on behalf of the Directors of Gotwick Limited, do solemnly and sincerely declare as follows :

1. The Directors at Gotwick Limited are and have been since 8th October 1986 the owner of the land known as the Gotwick Estate more particularly delineated on the plan accompanying this Declaration and thereon edged red.
2. On the 18th day of October 2001 the previous agents for the Directors of the Gotwick Estate named Messrs Knight Frank deposited with Surrey County Council being the appropriate Council a Statement accompanied by a plan delineating our client's property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration have been dedicated as footpaths.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the Statement dated 18th October 2001 referred to in 2 above, and at the present time the Directors of Gotwick Limited have no intention of dedicating any more public rights of way over their property.


