

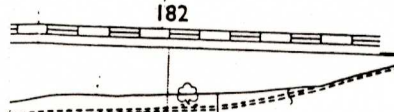
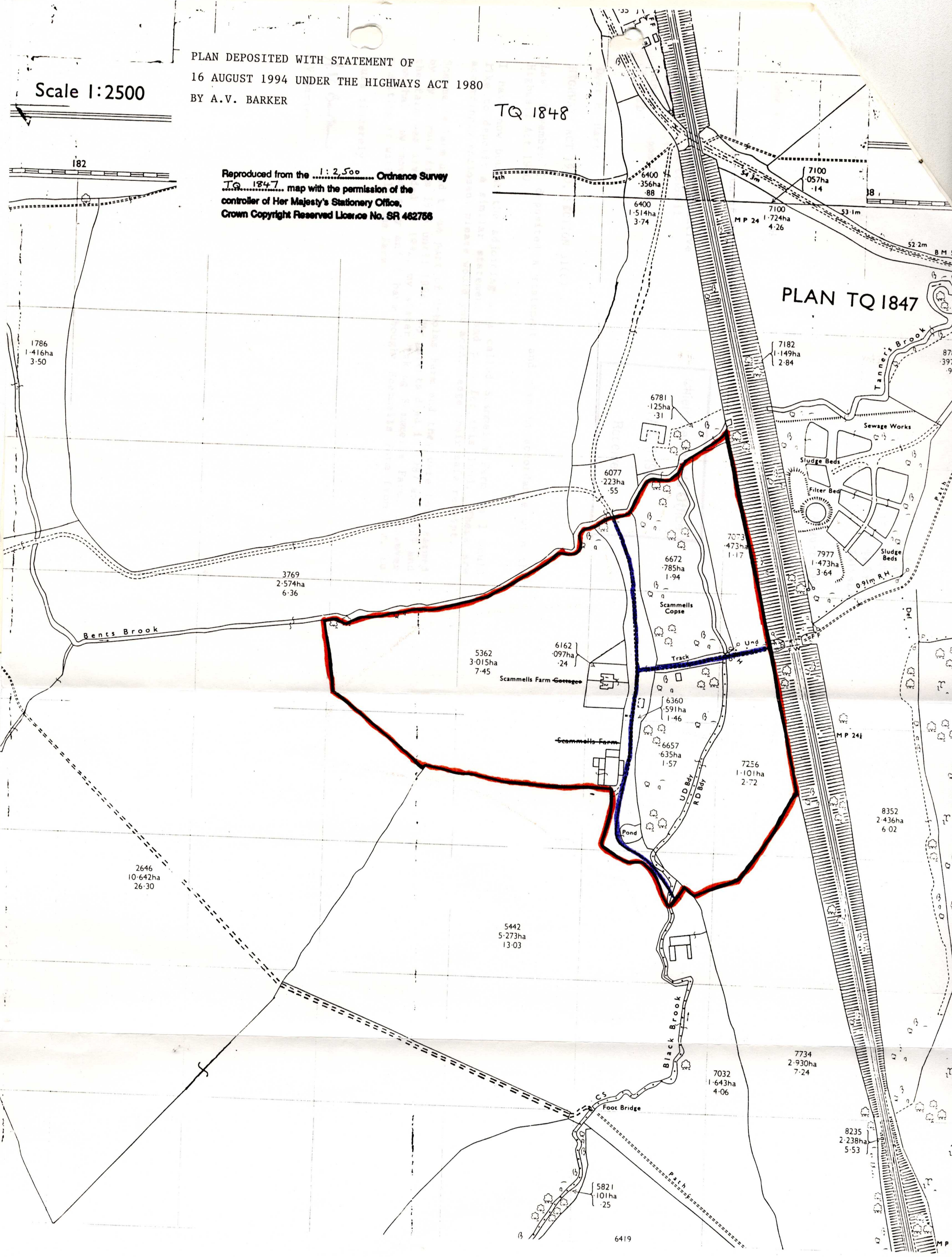

To Surrey County Council


