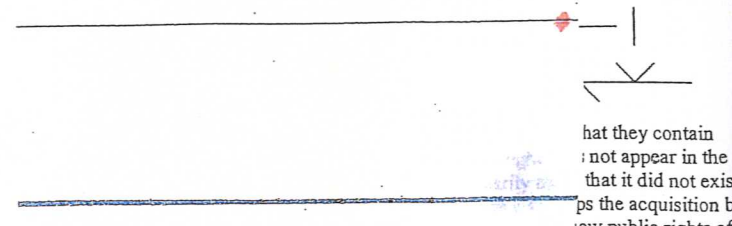


I Donald Charles MacKenzie Andrews of Tego House Chippenham Drive Kingston Milton Keynes MK10 0AF do solemnly and sincerely declare that:

1. I am a director of Laporte Industries Ltd ("the Company"). I am duly authorised to make this declaration on behalf of the Company in connection with a deposit of statement and map pursuant to section 31(6) of the Highways Act 1980.
2. The Company is the owner of the land at Nutfield Road, Redhill, Surrey ("the Land") shown for identification purposes only edged red on the plan now produced and shown to me marked "DCMA1" which is to the best of my knowledge and belief accurate.
3. On 6 October 2005 I (through Kent Jones and Done Solicitors) deposited with Surrey County Council, being the appropriate Council a statement dated 4 October 2005 accompanied by a map identifying the Land by red edging which stated that the ways shown coloured purple on the said map and on the plan at "DCMA1" have been dedicated as footpaths over or near to the Land.
4. No additional ways have been dedicated over the Land since the statement dated 4 October 2005 referred to in paragraph 3 above and at the present time the Company has no intention of dedicating any more public rights of way over the Land.
