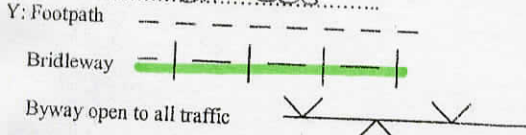

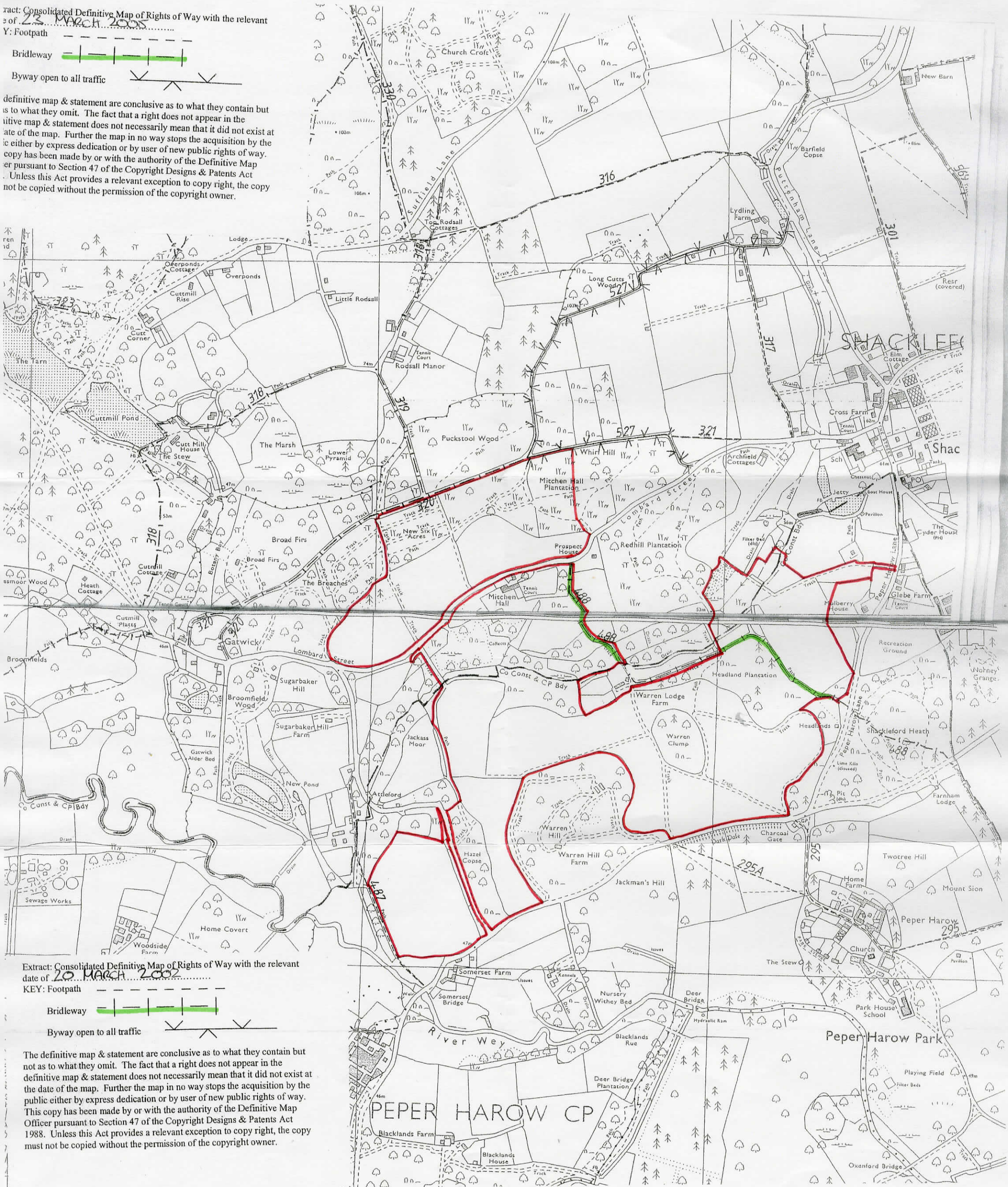

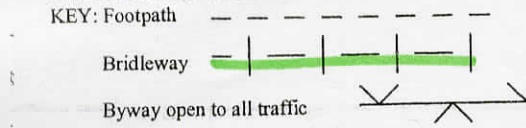
Extract: Consolidated Definitive Map of Rights of Way with the relevant date of 23 March 2005
