3. In June 2012, I deposited with the Council, being the appropriate Council, a declaration dated 1st June stating that no additional ways had been dedicated as footpaths since the deposit of the statement referred to in paragraph 2 above.

4. No additional ways have been dedicated over the land on the map referred to in paragraph 1 above since the statement dated 1st July 2005 referred to in paragraph 2 above and at the present time the owners have no intention of dedicating any more rights of way over the property.


