

I, ALFRED CYRIL FRANCIS EVANS of 1554 Athlone Drive, Victoria, British Columbia, Canada do solemnly and sincerely declare as follows:-

1. I am the owner of the freehold of the agricultural land edged red on the plan attached hereto situate at The Hart, Farnham, Surrey and marked 'ACFE 1'.
2. I inherited the property about 20 years ago from my mother who in turn inherited the property from her father the late Mr. A.H. Stevens in about 1934.
3. Up to a few years ago the land was used with the adjoining land as hop fields but in recent years has been used for agricultural purposes.
4. I recognize the right of the public to use the public footpaths number 6, 7, and 181 shown on the plan and coloured blue insofar as they affect the land I own, but in recent years since hops ceased to be grown, the public have started to use the paths coloured brown on the said plan. My tenant Mr. Keith Kenward and I are trying to prevent them using such brown paths by putting up notices to show the line of the official public footpaths, which have been already dedicated and I hereby declare that the footpaths coloured brown have not been dedicated for use by the public.
5. I depose from my knowledge as aforesaid and I make this solemn declaration believing the same to be true and by virtue of the Statutory Declarations Act 1835.

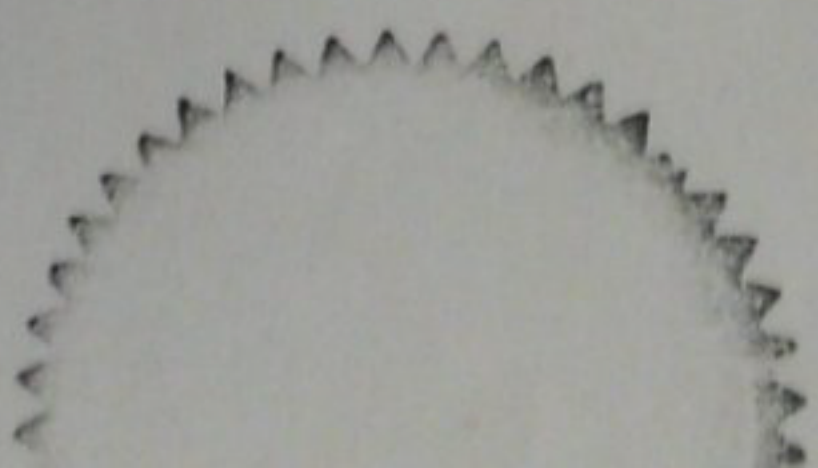
