I Philip David Robbins, Solicitor of Barlow Robbins LLP, Concord House, 165 Church Street East, Woking, Surrey, GU21 6HJ make this statement on behalf of the freehold owners of Horsell Common and adjacent land being Philip David Robbins of Lindisfarne, Heath Road, Woking, Surrey, GU21 4DT, Victor Duckett of 19 Hale Place, Monkton Lane, Farnham, Surrey, GU9 9BJ and Timothy Richard Harris of Penylan, Heathside, Park Road, Woking, Surrey, GU22 7JE (acting as Trustees of the Horsell Common Preservation Society) being the registered proprietors of Horsell Common and adjacent land, registered at HM Land Registry under title number SY350625, SY670656, SY444683, SY720058, SY646115, SY653374, SY670083, SY594474, SY717730 and SY752077.

I am depositing herewith a plan showing the land owned by the Trustees edged in red by way of a deposit of plan under section 31(6) of the Highways Act 1980.

I admit that the following rights of way for pedestrian users only marked in yellow on the plan have been dedicated as footpaths;

- **FP6** (from the South West corner of Littlewick Common to the Northern point of that common)
- **FP116** (from Claydon Road Horsell to High Street Horsell)
- **FP4** (from Station Road Chobham to Littlewick Road Horsell)
- **FP4a** (from High Street Horsell to South Road Horsell)
- **FP117** (from Morton Road Horsell to Chobham Road Horsell)
- **FP113** (being a short length of footpath along the River Bourne to BW404)
- **FP1** (from Mizens Farm (now McLaren Headquarters) to Anthony's Horsell)
- **FP120** (a short length of track from FP4 to Station Road Chobham)
- **FP19** (from Horsell Park to Brewery Road across Horsell Moor)
- **FP19a** (from Horsell Park to Brewery Road across Horsell Moor)
- **FP114** (from Well Lane along Well Path)

- I also admit that **BW2 (Woking) and BW404** (from Fairoaks Airport along Young Stroat Lane to Horsell Common and then West past Shaws Farm and Wapshott Farm) have been dedicated as a bridleways.

I confirm and declare that no other highway, bridleway, footpath or other route has been dedicated for use by the public by Philip David Robbins, Victor Duckett and Timothy Richard Harris or their predecessors in title as Trustees of the Horsell Common Preservation Society.

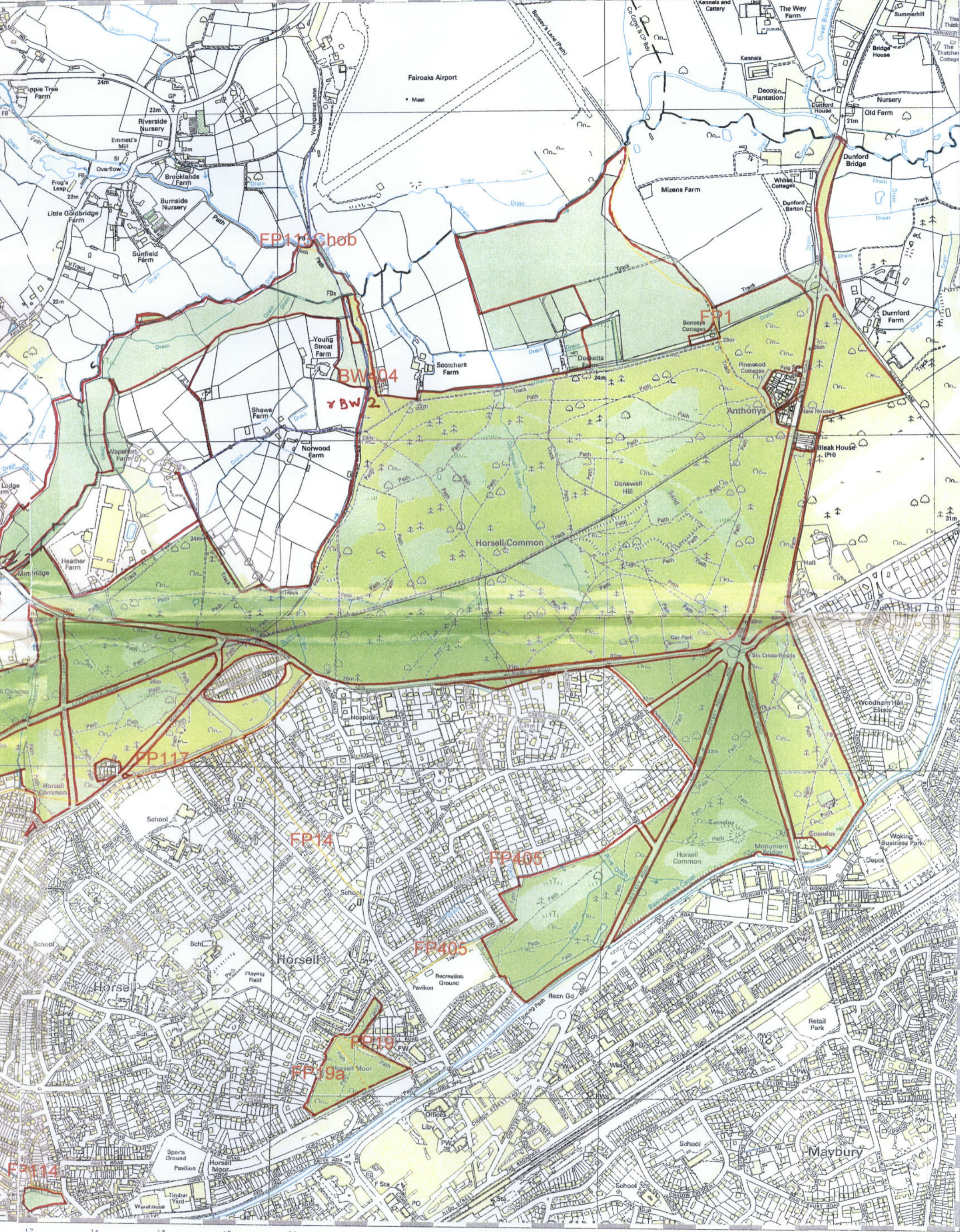
