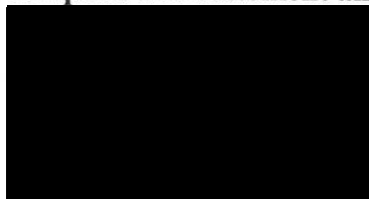


DEPOSIT OF STATEMENT and PLAN
SECTION 31(6) OF THE HIGHWAYS ACT 1980

To Surrey County Council

1. Surrey County Council is and has been since 27th September 1947, 13th October 1947 and 16th April 1962, the owner within the meaning of the above section of the land known as Chobham Youth Centre in Windsor Road, Chobham, more particularly delineated on the plan accompanying this statement and thereon edged red.

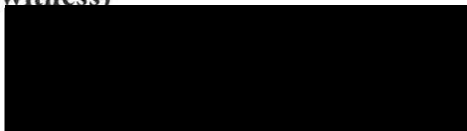

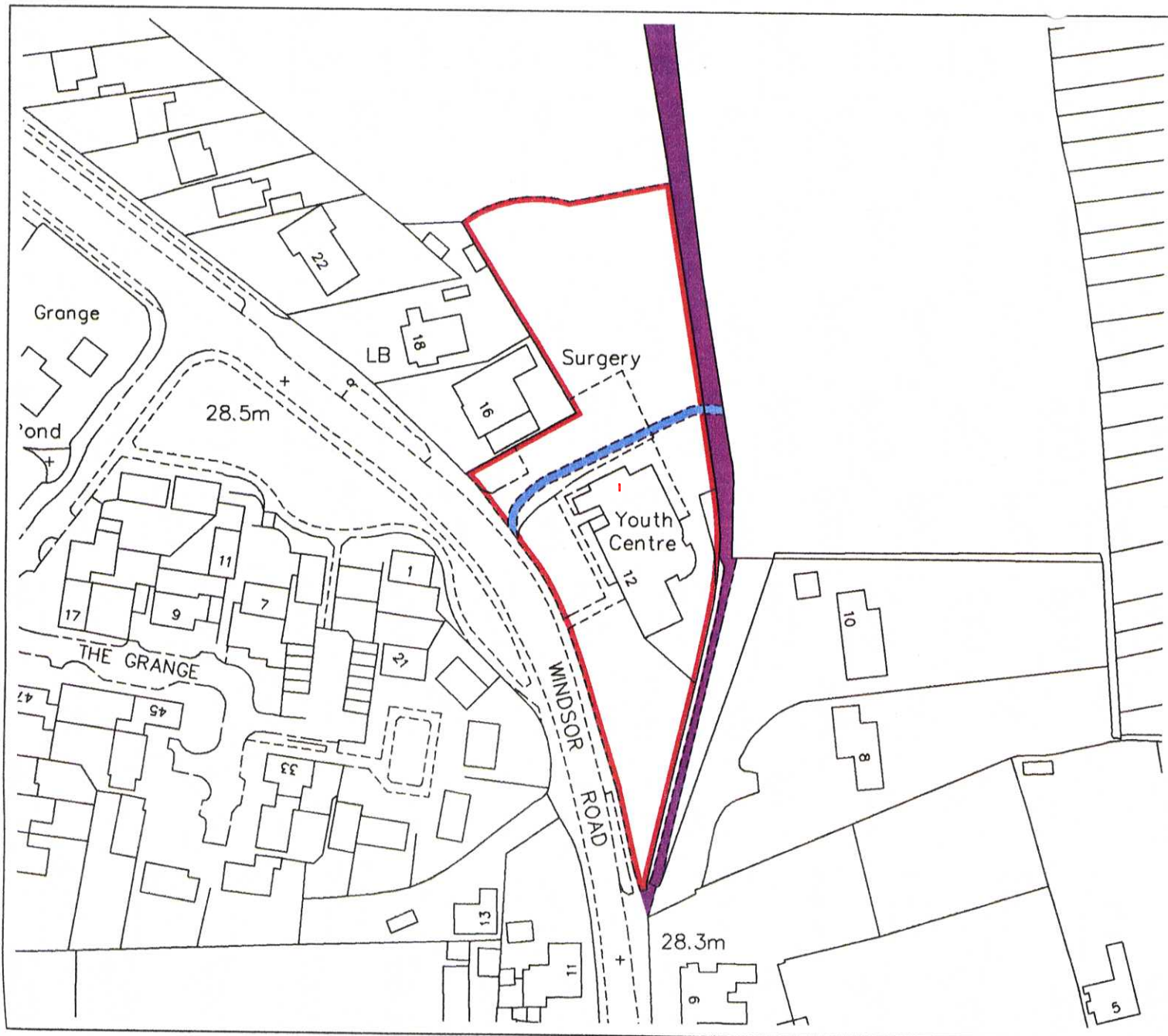
