

STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

I, Keith Barker of Surrey County Council, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. Surrey County Council is and has been since 27th September 1947, 13th October 1947 and 16th April 1962, the owner of the land known as Chobham Youth Centre in Windsor Road, Chobham, more particularly delineated on the plan accompanying this declaration and thereon edged red.

2. In lieu of my Statutory Declaration of 23rd September 2003, I deposit with Surrey County Council, being the appropriate authority, a new Statutory Declaration accompanied by a plan delineating my property by red edging and showing that the ways coloured purple on the plan have been dedicated as footpaths.

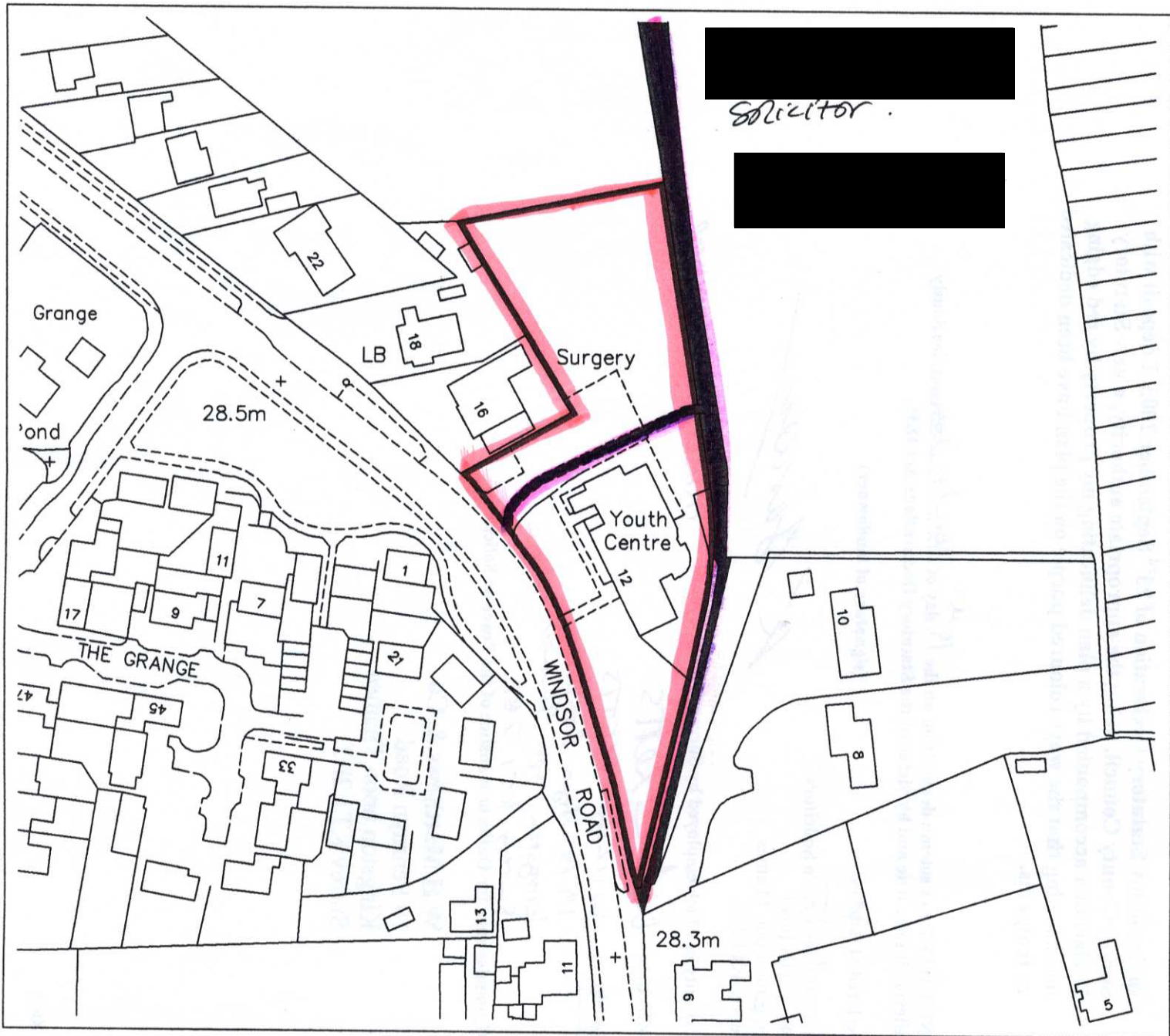
