relating to public rights of way and land at Inholms Farm, Scammells Farm, Beldhams Farm and Hilly 6 Acre near Dorking

STATUTORY DECLARATION

Section 31(6) of the Highways Act 1980

- I, Alan Vernon Barker of Inholms Farm, Stonebridge, Dorking, Surrey RH5 4DR, solemnly and sincerely declare as follows:
- 1. On 1 November 2002 I lodged with the Surrey County Council ("the Council") a statutory declaration ("the 2002 declaration") pursuant to Section 31(6) of the Highways Act 1980. The areas of land referred to in the 2002 declaration and in an earlier statutory declaration of 1996 as respectively "the red land" and "the green land" are similarly referred to below. The 2002 declaration stated that no additional ways over the red land or the green land had been dedicated as highways since I lodged with the Council that earlier statutory declaration of 1996.
- 2. On 31 July 2002 I deposited with the Council a statement pursuant to the said Section 31(6) ("the Beldhams Farm statement"). The Beldhams Farm statement was accompanied by a plan delineating the land edged red thereon and known as Beldhams Farm ("the Beldhams Farm land") and stated that no ways over the Beldhams Farm land had been dedicated as highways.
- 3. On 2 August 2005 I deposited with the Council a statement pursuant to the said Section 31(6) ("the Hilly 6 Acre statement"). The Hilly 6 Acre statement was accompanied by a plan delineating the land edged red thereon and known as Hilly 6 Acre ("the Hilly 6 Acre land") and stated that no ways over the Hilly 6 Acre land had been dedicated as highways.
- 4. I continue to be the owner of the red land, the green land, the Beldhams Farm land and the Hilly 6 Acre land.
- 5. No ways have been dedicated as highways:
- (i) over the red land or the green land since I lodged the 2002 declaration,
- (ii) over the Beldhams Farm land since I deposited the Beldhams Farm statement, or
- (iii) over the Hilly 6 Acre land since I deposited the Hilly 6 Acre statement.
- 6. At the present time I have no intention of dedicating as a highway any additional way over the red land or the green land or any way over the Beldhams Farm land or the Hilly 6 Acre land.

And I make this solemn declaration conscientiously believing the same to be true and

by virtue of the provisions of the Statutory Declarations Act 1835.
