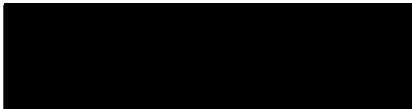
UNDER SECTION 31(6) HIGHWAYS ACT, 1980

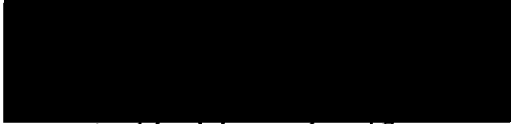
