

STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

~~* 5 Upon the said plan there is marked in blue a path for which I give consent to members of the public to walk/ride over. However, this path is not being dedicated to the public at large to use.~~

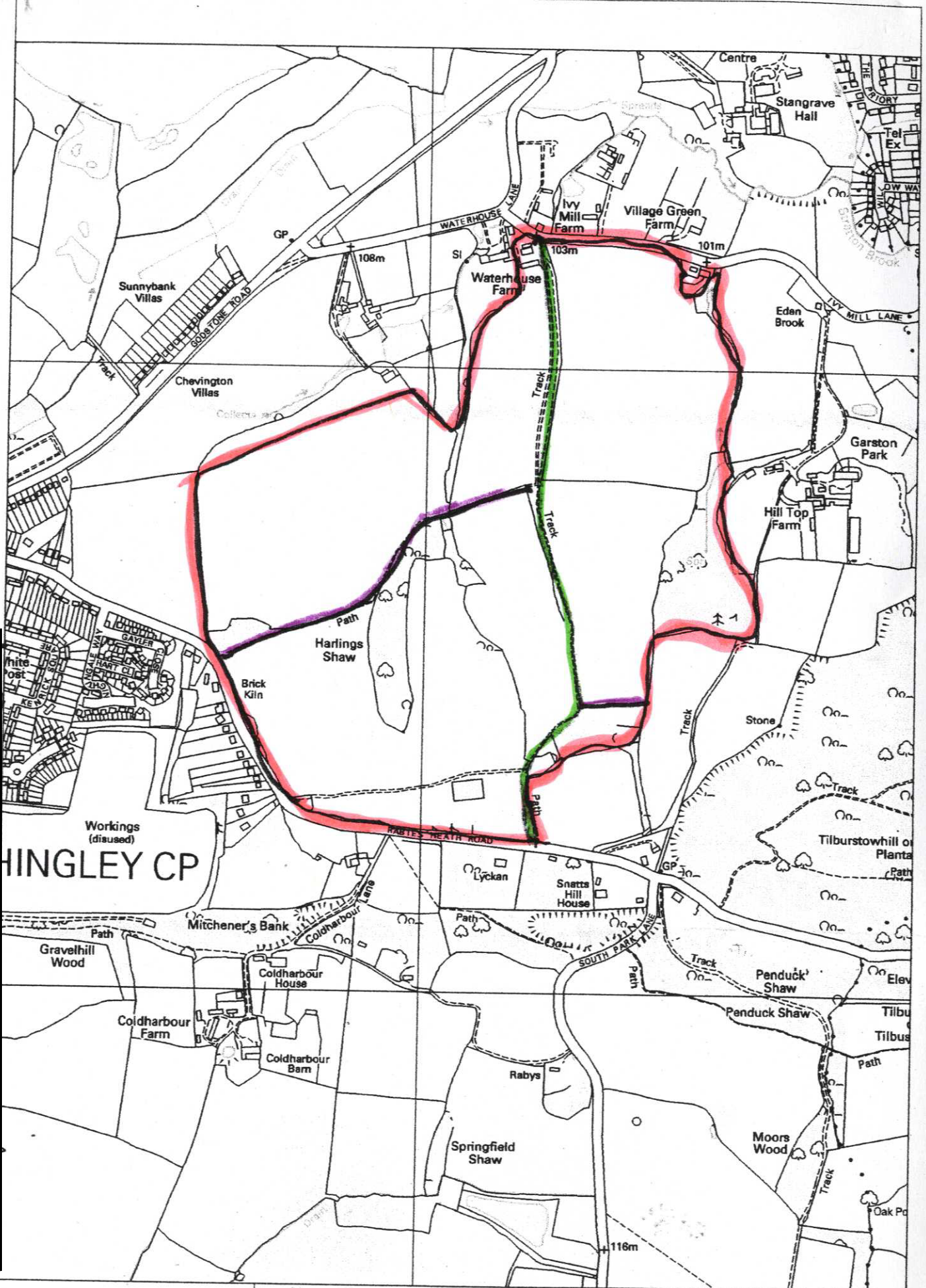
