

**STATUTORY DECLARATION**  
**SECTION 31(6) OF THE HIGHWAYS ACT 1980**

KEITH KENWARD [landowner] DO SOLEMNLY AND SINCERELY DECLARE as follows:-

- 1 I am and have been since MAY 1992 [day, month, year] the owner of the land known as COXBRIDGE FARM [name of farm, etc] more particularly delineated on the plan accompanying this declaration and thereon edged red.

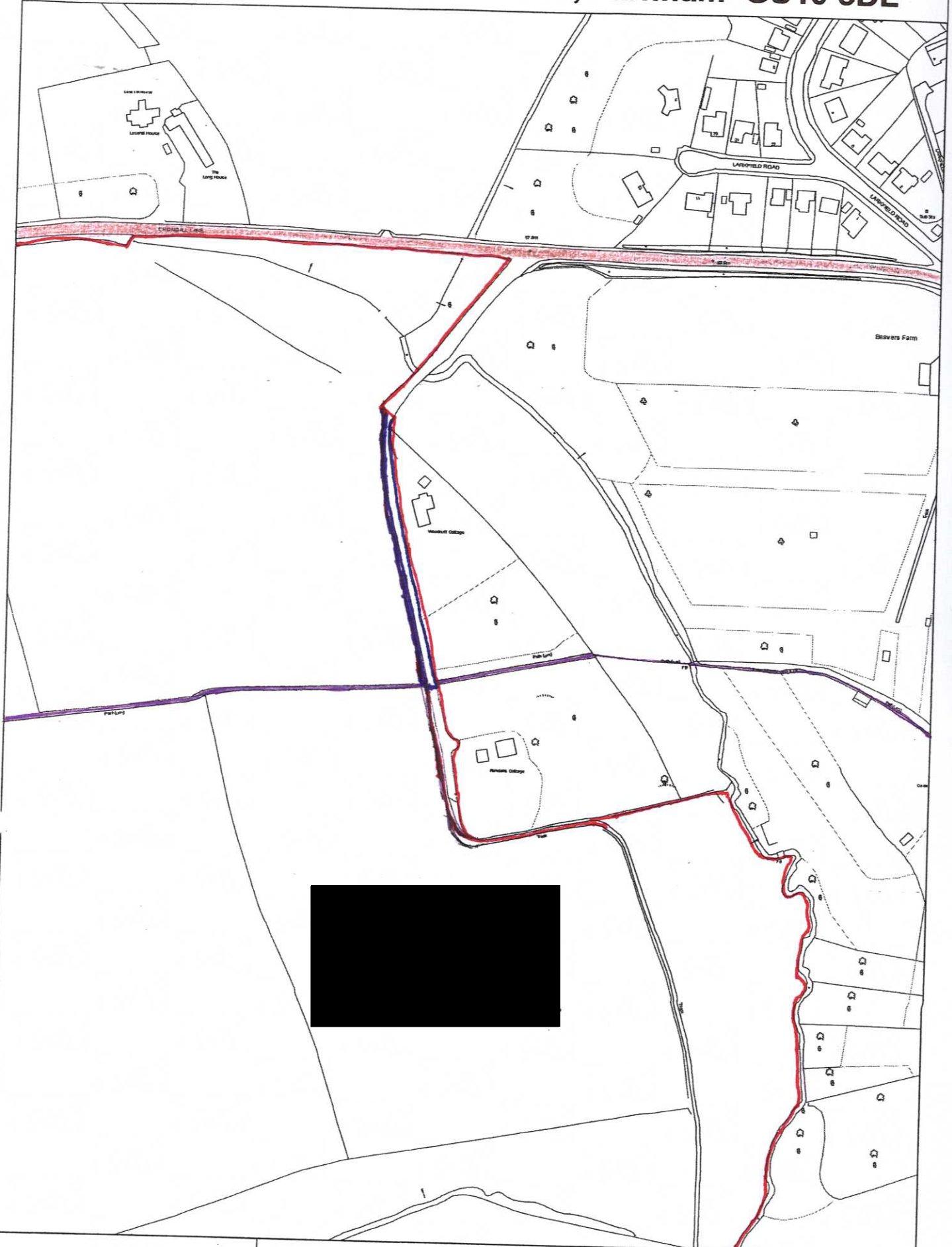
