

STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

We Mr and Mrs A Chandler [landowner] DO SOLEMNLY AND SINCERELY DECLARE as follows:-

1 We have been since 18 January 2001 [day, month, year] the owners of the land known as land to the north east and south of Sandy Cross House [name of farm, etc] more particularly delineated on the plan accompanying this declaration and thereon edged red.

2 On the ^{February} 9th [day] day of ~~January~~ 2012 [month, year] we (or my predecessor in title [name]) deposited with Surrey County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that ~~(the ways coloured brown on the said plan and on the plan accompanying this declaration had been dedicated as highways with public vehicular status*) (the ways coloured plum on the said plan and on the plan accompanying this declaration have been dedicated as restricted byways*) (the ways coloured green on the said plan and on the plan accompanying this declaration had been dedicated as bridleways*) (the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths*) (no ways had been dedicated as highways over my property*)~~.

3 On the ^{February} 9th [day] day of ~~January~~ 2012 [month, year] we (or my predecessor in title [name]) deposited with Surrey County Council, being the appropriate Council, a statutory declaration dated ⁹ ~~January~~ 2012 [day, month, year], stating that no additional ways (other than those coloured on the plan accompanying this declaration) had been dedicated as ~~(highways with vehicular status*) (bridleways*) (footpaths*)~~ since the deposit of the Statement referred to in paragraph 2 above.

4 ~~No additional ways have been dedicated over the land edged red on the plan accompanying this declaration (since the statement dated [day, month, year] referred to in paragraph 2 above*) (since the date of the statutory declaration referred to in paragraph 3 above*) (other than those (highways with vehicular status*) (restricted byways*) (bridleways*) (footpaths*) coloured on the plan accompanying this declaration*).~~

5 ~~Upon the said plan there is marked in blue a path for which I give consent to members of the public to walk/ride over. However, this path is not being dedicated to the public at large to use.~~
